**A RESOLUTION TO AUTHORIZE THE MAYOR TO ACCEPT TREE REMOVAL SERVICES AT 606 MODOC LANE FROM GREEN FUTURE CONSTRUCTION IN THE AMOUNT OF \$2,950.00**

**WHEREAS**, The Town of Forest Heights (the "Town") has agreed to accept Green Future Construction to perform tree removal services at 606 Modoc Lane; and

**WHEREAS**, the will pay Green Future Construction to perform tree removal services in the amount of \$2,950 from line item 8008 – Snow Removal/Tree Removal; and

**NOW THEREFORE, BE IT RESOLVED** that the Mayor and Town Council of Town of Forest Heights, Maryland hereby agrees to accept Green Future Construction of Laurel, Maryland proposal (See Exhibit 1 — the accepted proposal with Green Future Construction); and

**FURTHER BE IT RESOLVED** that the Mayor and Town Council of The Town of Forest Heights, Maryland hereby agrees to accept Green Future Construction proposal by the terms and conditions of said agreement and authorizes the Mayor to execute on said contract;

**AND BE IT FURTHER RESOLVED** that this Resolution shall take effect upon its passage.
