A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF FOREST HEIGHTS, MARYLAND APPROVING AND AUTHORIZING AN ADDITIONAL EXTENSION OF RENOVATION OF THE CONSTRUCTION CONTRACT FOR THE NEW POLICE & PUBLIC WORKS DEPARTMENTS' EXISTING BUILDING RENOVATION AND ADDITION AT 606 MODOC LANE

WHEREAS, the Town Council has authority to approve contracts and procurements pursuant to the Town Charter, Section 33-63, and Town Code, Section 20.4; and

WHEREAS, on or about October 3, 2016 by Resolution 62-16, the Town Council approved the amended contract of Monument Enterprises, LLC of Upper Marlboro, MD entitled proposal in the amount of \$420,000 regarding the renovation of 606 Modoc Lane (Phase II); and

WHEREAS, on December 21, 2017 the Council approved an extension until January 31, 2017 and due to weather conditions and the permitting process with Prince George's County the timeline for the completion of the renovation needs to be extended until the end of March 2017; and

NOW THEREFORE BE IT RESOLVED, the Council finds that it is in the best interest of the Town to authorize the Mayor to extend the renovation of 606 Modoc Lane;

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon its passage.
