### **Ballot Update to 2013 Town Election**

Ward III Councilman Larry M. Stoner will not be on the election ballot for this year's Town Election to be held on March 13, 2013. Councilman Stoner had intended to run for the position of Mayor. An explanation follows:

In October 2012, the Town Council passed Charter Amendment Resolution No. 03-12 ("CAR 03-12"), which had been introduced in September by Ward I Councilman Robert Barnes, Jr. As residents are well aware, the Town Council consists of a Mayor and six Councilmen (two from each of the 3 Town Wards). Half of these Councilmen have terms that run concurrently, or at the same time, as the Mayor while the remaining Councilmen have terms that expire the following year. The intent of Charter Amendment Resolution 03-12 was to establish that any seated Councilman who has a term of office running **non-concurrently** (i.e. not at the same time) with the Mayor's term and who wishes to run for the office of Mayor at the next general election must give up his/her seat (after the subsequent general election) on the Town Council upon filing a certificate of nomination for the office of Mayor.

CAR 03-12 was created to "level the playing field" for all current and future candidates for Town Council since those Councilmen who do not have the same term as the Mayor would have been able to keep their seats on the Town Council if running for Mayor, whereas the Councilmen whose terms run concurrently with the Mayor and who decided to run for Mayor instead of retiring from elective office would have to choose either to run for Mayor or run for Council but not both. The Town Charter has now for many years prohibited a person from filing more than one certificate of nomination (i.e., for multiple offices) during a general election, and it does not allow a person to hold more than one elected office at the same time.

In addition to the long-standing February deadline for filing certificates of nomination required of all other candidates, CAR 03-12 also states that a Councilman who intends to run for the office of Mayor and is in mid-term (i.e., whose term is not concurrent with the Mayor's term) must file a certificate of nomination on or before the first Wednesday of January so that eligible residents would have notice and could file their own certificates in February to run for either a two-year or a one-year term for the vacated seats. According to records, Mr. Stoner did not file his certificate of nomination until February (i.e., the second deadline that applies to non-incumbents). Councilman Stoner maintained that Charter Amendment Resolution 03-12 was defective and should not apply to him essentially because it contained some errors and that he should be allowed to file in February with the other candidates regardless of the new January deadline established for mid-year councilmen running for Mayor. The Council, however, found that the errors were merely typographical or minor (i.e. the word "concurrently" was used in places where it clearly meant "non-concurrently").

Due to misinformation or lack there of, the Town Board of Elections mistakenly allowed for Councilman Stoner's name to be placed initially on the ballot for the 2013 election. An appeal was filed against Councilman Stoner's candidacy for the office of Mayor. The typographical issues were later discussed at the March 4 Council Workshop, and the Town Council adopted and passed CAR 01-13 to address those errors. At that same workshop, an appeal was heard and Councilman Barnes and Councilman Stoner were both given the opportunity to present their cases to the Town Council. After hearing both sides, reviewing all the available evidence and deciding the proper interpretation of the law as was intended by CAR 03-12, the Town Council voted to remove Councilman Stoner's name from the ballot for the office of Mayor at the upcoming March 2013 general election, and reversed the decision of the Town Board of Elections to certify Councilman Stoner's nomination. Mayor Jacqueline Goodall recused herself from the final vote, and left the room while the vote had taken place. The Town Council further admonished Councilman Stoner for not properly following the Charter requirements.

Councilman Stoner had no further comment at this time. Councilman Stoner has a right to appeal the Council's decision to the Circuit Court, and he has a right to conduct a write-in campaign if he wishes. Anyone wishing to obtain a copy of Charter Amendment Resolution 03-12, Charter Amendment Resolution 01-13 or Town Resolution 20-13 (the Council's decision to reverse the Board's decision) may call the Town Clerk's Office or check the Town website.

### FOREST HEIGHTS POLICE DEPARTMENT



In light of the recent controversy over speed camera devices throughout the state of Maryland the citizens of Forest Heights should know that the town's camera is in fact reducing the likelihood that speeding motorists could cause serious accidents resulting in property damage, injury and loss of life. In a recent report to the Maryland State Highway Administration based on the collected data from the town's camera, there has been a reduction in speed along both directions in the MD 210 corridor. From July 2011 to August 2012 there were only 3 reported crashes. This represents a reduction of minus 63% since before the cameras were active. The number of drivers exceeding the speed limit by 11 to 20 miles per hour has been reduced by over 95%. The source of this information is attributed to The Traffic Group Inc., Traffic Engineers and Transportation Planners.

During recent conversations with Mayor Jacqueline Goodall and Police Liaison Councilman Jonathon Kennedy II, there is growing concern over the distribution of Controlled Dangerous Substances in certain areas in Forest Heights. These areas fall within the 1000 feet limit of the town's two schools. This is a Felony subject to \$20,000.00 fine and/or 20 years sentence. Subsequent violations can result in a \$40,000.00 fine and /or a 40 year sentence. Mayor Goodall stressed she has a no tolerance stance in this matter and violators will be dealt with accordingly. As always FHPD appreciates any information on criminal activity and neighborhood involvement. Remember this is your town don't be afraid to take it back.

### Forest Heights Plaque Presented to Maryland Municipal League

We would like to thank and acknowledge our town attorney Kevin J. Best for his act of kindness last month. During one of his business trips to the Maryland Municipal League's headquarters in Annapolis, Attorney Best noticed that the League's Board of Directors had a wall display containing plaques from over a hundred municipalities in the State of Maryland, but that Forest Heights did not have a plaque on the wall. He then took it upon himself to get a plaque custom-made with the Town of Forest Heights logo and slogan so that the town could be better represented. He presented the plaque to the MML Board of Directors Feb. 21 in Annapolis.

### Town Council Opposes Bill on Speed Camera Restrictions

The Town Council voted on a resolution at the Feb. 4 workshop to send a letter to representatives of the Maryland General Assembly and Maryland Municipal League urging opposition against Senate Bill 207. The bill would limit the placement of speed monitoring systems in school zones and place other restrictions on speed monitoring or speed control systems in the State of Maryland. The House version of the bill (HB 251) would also revoke the authority of counties and municipalities in the State to use speed monitoring systems to enforce highway speed laws.

### Vice Chairman Patterson Hosts Winter Community Coffee Event

District 8 County Councilman Obie Patterson, who is now Vice Chairman of the Prince George's County Council, hosted a Community Coffee event Feb. 15 at the Safeway Starbucks off Swan Creek Road in Fort Washington. Patterson said the new Southern Regional Tech/Rec Complex located off Bock Road in Fort Washington is expected to open later this spring, as well as the Allentown Splash, Tennis and Fitness Park, which closed last year for renovations. Patterson also provided updates to current/upcoming development projects. Later he introduced Maj. Raphael Grant, the new commander for the Prince George's Police Department's District IV - Oxon Hill station, who updated residents on the latest public safety news.

### FY 2014 Budget for Prince George's County

Prince George's County Executive Rushern L. Baker III hosted three public hearings to solicit feedback on the county's fiscal year 2014 budget. The county projects a \$152.2 million deficit for 2014. General fund revenues are forecasted to be lower than fiscal year 2013 budgeted levels — approximately \$2.65 billion, a decrease of \$24 million or 0.9 percent from fiscal year 2013 estimated revenues. "This is going to be very difficult," he said at a Feb. 6 public hearing at Friendly High School in Fort Washington. "There will be cuts, and unfortunately, there will not be any department that will be spared." Baker will need to submit his budget by March 15. The County Council will have until June 1 to review it.

Due to reductions in staff, the Prince George's County Memorial Library System made the decision to cease sales of Senior SmarTrip® cards. Since January 2012, this decision has resulted in less convenience for senior citizens living in Prince George's County.

offices, County-operated commuter stores, and some public libraries located in Montgomery County.

Metro is committed to working with Prince George's County government to resolve this situation. Following a meeting between Metro staff and the Library System in September 2012, the Library System reaffirmed its concerns about shrinking staff, managing inventory of Senior SmarTrip® cards and collecting and keeping the separate fees. Metro will continue to work with the Library System to determine if alternatives, such as fewer locations or limiting sales to specific hours of the day, could alleviate some of these concerns.

Additionally, Metro has reached out to the Prince George's Department of Parks and Recreation to determine if Senior SmarTrip® card sales at any of its facilities could be feasible. The County is currently reviewing the feasibility of this concept.

Recognizing that seniors in Prince George's County need more convenient options for purchasing Senior SmarTrip® cards, Delegate Doyle Niemann has proposed bi-county legislation during the 2013 session of the Maryland General Assembly. Sponsored by the Montgomery and Prince George's County Delegations, HB 1239 would require the Washington Suburban Transit Commission (WSTC) to enter into a contract or agreement with Metro to establish three sales outlets in Prince George's County. Given that WSTC is a small organization (with three employees in one office location and a limited budget), Metro believes that working with Prince George's County government will yield a better resolution.

The goal established in HB 1239 of having three sales outlets in Prince George's County is very modest, and ideally Metro and Prince George's County will be able to exceed that target.

### 5 Things You Never Knew Your Cell Phone Could Do

- -- For all the folks with cell phones. (This should be printed and kept in your car, purse, and wallet. Good information to have with you.)
- -- There are a few things that can be done in times of grave emergencies.
- -- Your mobile phone can actually be a life saver or an emergency tool for survival.
- -- Check out the things that you can do with it:

#### FIRST (Emergency)

--The Emergency Number worldwide for Mobile is 112. If you find yourself out of the coverage area of your mobile network and there is an Emergency, dial 112 and the mobile will search any existing network to establish the emergency number for you, and interestingly, this number 112 can be dialed even if the keypad is locked. Try it out.

### **SECOND (Locked Keys in Car)**

- --Have you locked your keys in the car? Does your car have remote keyless entry? This may come in handy someday. Good reason to own a cell phone:
- --If you lock your keys In the car and the spare keys are at home, call someone at home on their cell phone from your cell phone. --Hold your cell phone about a foot from your car door and have the person at your home press the unlock button, holding it near the mobile phone on their end. Your car will unlock. Saves someone from having to drive your keys to you. Distance is no object. --You could be hundreds of miles away, and if you can reach someone who has the other 'remote' for your car, you can unlock the doors (or the trunk).

Editor's Note: It works fine! We tried it out and it unlocked our car over a cell phone!'

#### **THIRD (Hidden Battery Power)**

--Imagine your cell battery is very low. To activate, press the keys \*3370#. Your cell phone will restart with this reserve and the instrument will show a 50% increase in battery. This reserve will get charged when you charge your cell phone next time.

#### FOURTH (How to disable a STOLEN mobile phone?)

- --To check your Mobile phone's serial number, key in the following Digits on your phone: \*#06#.
- --A 15-digit code will appear on the screen. This number is unique to your handset. Write it down and keep it somewhere safe.
- --If your phone is stolen, you can phone your service provider and give them this code. They will then be able to block your handset so even if the thief changes the SIM card, your phone will be totally useless. You probably won't get your phone back, but at least you know that whoever stole it can't use/sell it either. If everybody does this, there would be no point in people stealing mobile phones.

### **FIFTH (Free Directory Service for Cells)**

--Cell phone companies are charging us \$1.00 to \$1.75 or more for 411 information calls when they don't have to. Most of us do not carry a telephone directory in our vehicle, which makes this situation even more of a problem. When you need to use the 411 information option, simply dial:

#### (800) FREE411 (800) FREE411 or (800) 373-3411 (800) 373-3411

- --Without incurring any charge at all. Program this into your cell phone now.
- -- This is sponsored by McDonalds.

### MARYLAND DAY MARCH 25th

Let us look at the history of our very special Maryland Flag. The black and gold quarters are of Lord Baltimore's family; this is the banner that came ashore on St. Clement's Island, March 25, 1634, thus MARYLAND DAY. This banner was used until the American Revolution in 1775 when it became "Politically Incorrect" to use such a flag of royalty. Charles Willson Peale was chosen to design the first of the "Seal Flags," to represent the State of Maryland.

During the Revolution the secession colors for those either fighting or at home became the red and white from the banner of the Crossland's, Lord Baltimore's mother's family. Black and gold ribbons were displayed by those in agreement with the union.

The banners were joined together in 1880 to establish the Maryland State Flag, which was first displayed at the 5<sup>th</sup> Regiment Armory in Baltimore in 1889.

Let us remember Maryland Day with pride and display our state flag.
