

TOWN ELECTIONS FOR THE MAYOR & COUNCILPERSON IN WARDS, I, II & III TO BE HELD WEDNESDAY, MARCH 11th, 2015 (2 SEATS IN WARD 3) 1 YEAR TERM & 2 YEAR TERM



Certificate of Nominations may be obtained from the Municipal Building.

Qualifications Mayor & Councilmen qualifications for office can be found in the Town Charter (Councilmen) Section 33–4. Qualifications. & (Mayor) Section 33–16. Qualifications.

If you have recently moved into Forest Heights from somewhere else in Prince George County or moved from one Ward to another Ward you must provide the County Board of Elections Supervisor with your new address or if you have never registered to vote in Prince George County, a voter registration application must be submitted to your local board of elections or the State Board of Elections at any time. However, applications must be postmarked by January 27, **2015**, to vote in the Town Election.

Registration applications may be obtained from the Municipal Building in Forest Heights, For any additional information regarding election registration, please contact the Town Clerk or the Prince George County Board of Elections at (301) 430-8020.

Absentee Voters may make an application in writing for an absentee ballot. The application must be received no later than 7 days before the election. The application shall contain an affidavit, which need not be under oath, but which shall set forth the information required. Please contact the Town Clerk of Forest Heights for additional information.

SPECIAL ISSUE

(Financial Disclosure Statement). The form will be available January 20, 2015 and must be filed with the Town Clerk annually by *all sitting Town Council members and candidates for Town elective office*. An incumbent Town elected official shall file a financial disclosure statement annually on or before the first Wednesday in February, preceding the Town election of each year for the preceding calendar year. A seated Councilman serving a term of office that expires non-concurrently with the Mayor and who wishes to file a certificate of nomination for Mayor pursuant to Section 33-3 of the Town Charter shall file his or her financial disclosure statement no later than first Wednesday in January. The Town Clerk may not accept any certificate of nomination unless a financial disclosure statement has been filed in proper form. An individual who is appointed to fill a vacancy in an elected office shall file a statement for the immediately preceding calendar year within 30 days after appointment. An individual who leaves an office for which a statement is required shall file a statement within 60 days after leaving the office.

• Town Meetings are always held on the third Wednesday at 8:00 p.m. Mayor/Council Workshop Sessions are held on the first Monday of each month (Tuesday when Monday is a holiday. Meetings are open to the public.

The Weatherization Assistance Program

Are you having difficulty paying your energy bills?

Does your home need energy efficiency retrofits?

According the US Dept. of Energy, "checking a home's insulation is one of the fastest and most cost effective ways to use a whole-house approach to reduce energy waste and make the most of your energy dollars."

The Collaboration of Towns is once again offering low to moderate income household's renovation, rehabilitation in conjunction with weatherization. Homeowner must meet income criteria and be willing to provide documentation that income is BELOW the following:

Income Table Household

(Veterans and/or Retired Homeowners will be given preference)

1 person: income below \$36,000 \$0 cost \$36,000-\$64,000 10%

3 people: income under \$58,080 \$0 cost \$58,080-\$82,300 10% 5 people: income under \$75,450 \$0 cost \$75,450-\$98,700 10%

2 people: income under \$51,600 \$0 cost \$51,600-\$73,100 10%

4 people: income under \$64,500 \$0 cost \$64,500-\$91,400 10%

6 people: income under \$81,050 \$0 cost \$81,050-\$106,000 10%

For all moderate income homeowners participating in this program (households with income limits that fall within 60% to 85% of State median income), MEA requests that all moderate income homeowners contribute at least 10% of the total project cost.

The following make the home ineligible for this opportunity:

Had an energy audit within the past 6 months; Aggressive dogs not being safely handled; Drug use;

Threats to auditor; Home is sealed too tight resulting in the inability of fumes to escape through natural ventilation;

Major roof issues; Major plumbing problems; Gas leak; Structurally inadequate; Rental property;
