

**THE TOWN OF FOREST HEIGHTS
RESOLUTION 02-15**

A RESOLUTION TO RESCIND OR NULLIFY THE AWARD OF A BID TO CONGRESSIONAL CONTRACTING, INC. TO PROVIDE FOR ROLPH DRIVE STORMWATER AND ROADWAY REHABILITATION CONSTRUCTION AND RELATED SERVICES AND TO RELEASE THE ASSOCIATED BONDS, AND GENERALLY RELATED TO A PUBLIC STREET RECONSTRUCTION PROJECT

WHEREAS, the Town received construction bids for the Rolph Drive Reconstruction project opened during a public meeting held on December 5th, 2014; and

WHEREAS, pursuant to the applicable County-Municipal Participation Agreement dated 2/28/14, the Town Council awarded the bid (Contract No. FHRFB 3-14) to a contractor known as Congressional Contracting, Inc. on December 17, 2014; and

WHEREAS, by letter dated January 20, 2015, said contractor requests that its bid be withdrawn based on a mutual decision of the parties and that the Town agree to release the bid bonds and any other bonds submitted regarding the project.

NOW THEREFORE, BE IT RESOLVED that the Mayor and Town Council of the Town of Forest Heights, Maryland hereby agrees and approves the request letter, Exhibit A, attached hereto and incorporated by reference herein, dated January 20, 2015 from Congressional Contracting, Inc. to withdraw its bid, and hereby rescinds the award of the bid to perform Contract No. FHRFB 3-14 as previously approved by this governing body; and

AND BE IT FURTHER RESOLVED that said contractor's bonding is hereby approved for release and the Mayor is authorized to inform the County Government and to sign said release on behalf of the Town; and

AND BE IT FURTHER RESOLVED that this Resolution shall take effect upon its passage.
