## The Town of Forest Heights Resolution 35-15

## A RESOLUTION DECLARING THE OFFICIAL INTENT OF THE TOWN OF FOREST HEIGHTS TO REIMBURSE EXPENDITURES TO BE INCURRED WITH RESPECT TO ROADWAY IMPROVEMENTS WITH THE PROCEEDS OF DEBT

**WHEREAS**, to facilitate an efficient borrowing program, The Town of Forest Heights (the "Issuer") intends to expend money on roadway projects prior to the issuance of debt by the Issuer for such purposes; and

**WHEREAS**, the Issuer intends to reimburse such expenditures from the proceeds of debt to be issued by the Issuer; and

**WHEREAS**, to comply with applicable provisions of the Internal Revenue Code of 1986, as amended, and Section 1.150-2 of the Income Tax Regulations, it is necessary, in order to reimburse such expenditures with the proceeds of tax-exempt debt, that the Issuer declare its official intent to make such a reimbursement of expenditures;

**NOW, THEREFORE, BE IT RESOLVED** by the Council of The Town of Forest Heights that, as evidenced by this Resolution, the Issuer intends to expend money on the cost of the acquisition, construction, and improvements of the capital projects described in <u>Exhibit A</u> attached hereto prior to the issuance of bonds or other debt obligations to reimburse such expenditures. With respect to such projects, the Issuer reasonably expects to issue debt obligations for these projects in the estimated maximum principal amount of Five Hundred Fifteen Thousand Dollars (\$515,000.00).

**AND BE IT FURTHER RESOLVED** that this Resolution shall become effective immediately upon its adoption.
