BE IT FURTHER RESOLVED, that pursuant to Subsections 21.2.C(8) and 21.2.I(2) of the Town Ordinance Code, Councilperson C. Lynn Smith-Barnes and Town Administrator Vern Haefele shall be assigned as the liaison to coordinate with said body and shall assist, as needed, in drafting the agenda, scheduling meetings, and in the preparation and distribution of meeting materials; and

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon its passage.
