**A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF FOREST
HEIGHTS, MARYLAND FORMALLY APPOINTING
THE YOUTH THEATER COMMITTEE**

WHEREAS, pursuant to Section 21.2.C(6) of the Town Ordinance Code, the Council hereby finds that the appointees meet the qualifications for office prescribed by law; and

NOW THEREFORE BE IT RESOLVED, and enacted that the Town Council hereby approves and ratifies the appointment of the following individuals as Youth Theater Committee of Forest Heights to serve for a one (1) year term as prescribed by Section 21.2 of the Town Ordinance Code or until their successors are duly appointed:

AND BE IT FURTHER RESOLVED, that the above-named appointees shall subscribe to and be administered by the Mayor the oath of office for the Youth Theater Committee pursuant to Section 33-84 of the Town Charter; and

BE IT FURTHER RESOLVED, that newly appointed Youth Theater Committee BJ Jenkins is hereby appointed to serve as Chair of the Committee unless and until the Committee votes to name a successor Chair; and

BE IT FURTHER RESOLVED, that pursuant to Subsections 21.2.C(8) and 21.2.I(2) of the Town Ordinance Code, Councilperson C. Lynn Smith-Barnes and Town Administrator Vern Haeefe shall be assigned as the liaison to coordinate with said body and shall assist, as needed, in drafting the agenda, scheduling meetings, and in the preparation and distribution of meeting materials; and

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon its passage.
