Call to order– 8:05 pm

Roll Call –CM Kennedy II; Mayor Goodall (arrived at 8:08 pm); Council President Mann (absent); CW Smith-Barnes; CM Barnes; CM McLaurin (left at 10:26 pm) & CW Muhammad were present

Approval of Agenda – motion by CW Smith-Barnes; seconded by CM McLaurin to approve the agenda as amended; all were in favor

Approval of Meeting Minutes – motion by CM McLaurin; seconded by CW Smith-Barnes to approve the meeting minutes from June 6 (Worksession Mtg.) & June 8 (Special Mtg.); all were in favor
