REVITALIZATION PROGRAMS APPLICATION AT AN EXPENDITURE UP TO

WHEREAS, the Town of Forest Heights (the “Town”) would like to hire Veronica Owens to write the upcoming Community Legacy FY2017 State Revitalization Programs Grant Application which is in need of financial and technical assistance from a grant writer; and

WHEREAS, the Maryland Department of Housing & Community Development Division of Neighborhood Revitalization FY2017 State Revitalization Programs Application Community Legacy Neighborhood Intervention (DHCD-CL) is soliciting proposals for projects and programs that will contribute to improve the Town by new investments in an older neighborhood and business district areas; and

WHEREAS, the Town of Forest Heights has been committed to working towards a Sustainable Community, and the Mayor and Council wishes to authorize the Mayor to make application for a grant writer from the above-named grant to further its stated objectives. In Exhibit A; and

NOW THEREFORE, BE IT RESOLVED that the Mayor and Town Council of The Town of Forest Heights, Maryland hereby authorized the Mayor to hire Veronica Owens as the grant writer for the DCHD-CL FY2017 State Revitalization Program Application to spend up to \$2,500 for the grant writer as stated in Exhibit A.
