A RESOLUTION TO ACCEPT THE TRANSPORTATION GRANT FROM THE MARYLAND DEPARTMENT OF TRANSPORTATION FOR THE TOWN OF FOREST HEIGHTS

WHEREAS, Chapter 143 of the 2016 Laws of Maryland (SB190-Budget Bill for Fiscal Year 2017) allocated a Special Fund appropriation of \$25,000,000 to the Maryland Department of Transportation for the purpose of providing transportation grants to municipal governments; and

WHEREAS, it further provided that these grants are to be allocated as provided in Section 8-405 of the Transportation Article (Computation of Highway User Revenues for Municipalities); and

WHEREAS, to be eligible to participate, the municipal government must agree to only expend these grant funds in accordance with Section 8-408 of the Transportation Article (Permitted uses of Highway User Revenues) and to report the use of these funds in accordance with Section 8-412 of the Article; and

WHEREAS, the Town of Forest Heights has submitted the certification of participation in the Transportation Grant Application to the Maryland Department of Transportation on August 4, 2016 and has received \$51,591.69 on September 28, 2016; and

BE IT RESOLVED that the Mayor and Town Council of The Town of Forest Heights, Maryland hereby agrees to accept the Transportation Grant from the Maryland Department of Transportation in the amount of \$51,591.69 for FY2017;

AND BE IT FURTHER RESOLVED that the \$51,591.69 be allocate to line item 6023 Highway User Revenue of the FY2017 Budget;

AND BE IT FURTHER RESOLVED that this Resolution shall take effect upon its passage.
