**A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF FOREST HEIGHTS, MARYLAND APPROVING AND AUTHORIZING THE EXTENSION OF RENOVATION OF THE CONSTRUCTION CONTRACT FOR THE NEW POLICE & PUBLIC WORKS DEPARTMENTS' EXISTING BUILDING RENOVATION AND ADDITION AT 606 MODOC LANE**

**WHEREAS**, the Town Council has authority to approve contracts and procurements pursuant to the Town Charter, Section 33-63, and Town Code, Section 20.4; and

**WHEREAS**, on or about October 3, 2016 by Resolution 62-16, the Town Council approved the amended contract of Monument Enterprises, LLC of Upper Marlboro, MD entitled proposal in the amount of \$420,000 regarding the renovation of 606 Modoc Lane (Phase II); and

**WHEREAS**, due to weather conditions and the permitting process with Prince George's County the timeline for the completion of the renovation needs to be extended until the end of January 2017; and

**NOW THEREFORE BE IT RESOLVED**, the Council finds that it is in the best interest of the Town to authorize the Mayor to extend the renovation of 606 Modoc Lane;

**BE IT FURTHER RESOLVED**, that this Resolution shall take effect immediately upon its passage.
