**A RESOLUTION TO DEADLINE AND/OR SELL GREEN CHEVY LUMINA**

**WHEREAS**, pursuant to Forest Heights Code (Article 20) Financial Management and Internal Controls, §20.4 (Procedures) subsections ((a) 8, 9, & 10), the legislative body has incorporated the procedures to dispose of equipment; and

**WHEREAS**, the Town of Forest Heights Administration Department currently has a green Chevy Lumina (VIN # 2G1WL52JX11178999) which is currently inoperable; and

**WHEREAS**, this vehicle requires extensive costly repairs; and

**WHEREAS**, the Town would like to explore various options so the Town can obtain the best dollar amount for the vehicle; and

**WHEREAS**, there shall be a transaction to dispose of said property hereby declared by the Town Council to be surplus property of the Town.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Town Council of Town of Forest Heights, Maryland hereby agrees to deadline and/or sell said green Chevy Lumina, and that said transaction shall comply with said §20.4 and shall be disposed of by competitive sale or by gift to a governmental or non-profit organization per the Mayor's discretion.

**AND BE IT FURTHER RESOLVED**, that this Resolution shall take effect upon its passage.






