A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF FOREST HEIGHTS APPROVING A CONTRIBUTION OF FUNDS TO THE MUSIC DEPARTMENT OF THE FOREST HEIGHTS ELEMENTARY SCHOOL, AND GENERALLY RELATING TO A CONTRIBUTION OF MUNICIPAL FUNDS

WHEREAS, certain students enrolled at the Forest Heights Elementary School have been invited to sing at an upcoming Miss America Pageant in Atlantic City, New Jersey, and Dr. Chester Brookover, the Principal of said school has requested that the Town provide assistance in defraying the expense of transportation to said extra-curricular activity; and

WHEREAS, pursuant to Section 17.8 (Conditions for Contribution of Municipal Funds or Services) of the Ordinance Code of the Town of Forest Heights, the Council may make a contribution of funds, or a grant supplied by the Town to support an extraordinary need of a public institution, program, facility or service in order to provide a direct and material benefit to a significant number of Town residents.

WHEREAS, the Mayor and Town Council finds that it is a public purpose and in the best interest of the Town to support and promote the Music Department of the Forest Heights Elementary School and further assist it in providing educational services and opportunities to the Town and its residents.

NOW THEREFORE BE IT RESOLVED that the Town Council hereby approves and authorizes the following:

Section 1

A contribution of funds in the amount of \$ 1,500.00 is hereby approved and authorized for the Music Department of the Forest Heights Elementary School.

Section 2

Said contribution provided in Section 1 shall be immediately made payable to the Forest Heights Elementary School or its music department/other affiliate. This contribution is to be paid using funds from Line Item 8030 Youth Programs of the FY 2014 budget.

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon its passage.


