## TOWN OF FOREST HEIGHTS RESOLUTION 92–13

## A RESOLUTION TO AUTHORIZE THE MAYOR TO DISTRIBUTE CHRISTMAS BONUS TO THE TOWN EMPLOYEES

WHEREAS, the Mayor and Council passed Resolution 55-13 on June 19, 2013 approving the Fiscal Year 2014 Budget for The Town of Forest Heights (the "Town"); and

**WHEREAS**, Section 33-46 of the Town Charter requires that no public money may be expended without having been appropriated by the Council; and

WHEREAS, Section 33-48 of the Town Charter requires that during any budget year no officer or employee of Town shall expend or contract to expend any money or incur any liability which by its terms involves the expenditure of money for any purpose, in excess of the amounts appropriated for or transferred to that general classification of expenditure; and

WHEREAS, each year the Mayor invites all employees to participate in a year end dinner in lieu of the dinner the Council authorizes the Mayor to issue a bonus; and

WHEREAS, the Council finds that it is an accepted and long-standing practice in the State of Maryland for municipal corporations to provide employee bonuses at the end of the calendar year in recognition of faithful public service and that it is in the best interest of the Town to do so at this time; and

NOW THEREFORE BE IT RESOLVED, that the Town Council authorizes the Mayor and Treasurer to provide additional compensation to the employees of the Town in the form of bonus in an amount not to exceed \$53.80 per employee; and

**BE IT FURTHER RESOLVED,** that each employee shall receive a bonus of at least \$53.80 as appreciation for their service to the Town for the pay period ending on or before December 31, 2013.

**BE IT FURTHER RESOLVED**, that said bonuses shall not exceed a combined sum of \$1,022.77 and shall be appropriated from Line Item #7005 of the Fiscal Year 2014 Town Budget.

**BE IT FURTHER RESOLVED**, that this Resolution shall take effect immediately upon passage. PASSED this 18<sup>th</sup> day of December 2013.
