**RESOLUTION 32-14 – Fiscal Year 2015 Tax Rates**

**INTRODUCED BY: MAYOR & TOWN COUNCIL**

**ENACTED:** June 5, 2014

**WHEREAS**, the Mayor and Town Council passed Ordinance No. 03-13 on July 22, 2013 making it effective for the tax year beginning July 1, 2014, and for each tax year thereafter unless altered by subsequent enactment of the Town Council, the classifications of property subject to municipal taxation, with respect to those properties, businesses or utilities located within the municipal boundaries of the Town of Forest Heights, shall be as enumerated herein below.

**BE IT RESOLVED** that the tax rates and waste removal fees for fiscal year 2015 for all real, personal and other property which is subject to taxation by the Town of Forest Heights and as previously approved pursuant to Resolution \_\_-14 regarding specifically the noncommercial real property tax rate that this year was not found to be exempt from the Constant Yield Tax Rate Law, are hereby restated, ratified and approved to be as follows:

Residential Real Property	\$	.6248	per \$100.00 of assessed valuation;
Commercial Real Property	\$	.6258	per \$100.00 of assessed valuation;
Business Personal Property	\$	1.75	per \$100.00 of assessed valuation;
Public Utility Property	\$	1.75	per \$100.00 of assessed valuation;
Waste Removal	\$	160.68	per household/flat fee.

**AND BE IT FURTHER RESOLVED**, that this Resolution shall take effect July 1, 2014.
