Fiscal Year 2014 Budget Amendment

INTRODUCED BY: MAYOR & TOWN COUNCIL

ENACTED: June 30, 2014

A resolution to amend sums and amounts for the Fiscal Year beginning July 1, 2013 and ending June 30, 2014.

Section 1. The general purpose of the Resolution is to amend sums and amounts appropriated for the 2013-2014 Budget of the Town of Forest Heights, Maryland in the following areas of the General Fund.

Section 2. BE IT RESOLVED by the Mayor and Town Council of the Town of Forest Heights, Maryland that the sums and amounts appropriated are hereby amended for the Fiscal Year beginning July 1, 2013 and ending June 30, 2014, to defray expenses and operations costs for the Town of Forest Heights as follows:
