A RESOLUTION TO APPROVE A PROPOSAL AND INVOICE FROM KC DELIVERY SERVICE GENERAL CONTRACTING, LLC TO PROVIDE EXCAVATION, RETAINING WALLS, AND OTHER IMPROVEMENTS OF TOT LOT AT MOHICAN DRIVE AND FOX WAY

WHEREAS, the Director of Public Works obtained quotes to conduct certain work and install improvements at the subject tot lot; and

WHEREAS, a proposal (No. 115-14) and invoice dated 9/17/14 was received from KC Delivery Service General Contracting, LLC to excavate the tot lot at Mohican Drive and Fox Way to install a 6" x 6" retaining wall, rebar, 16 concrete deadheads, an ADA concrete ramp, backfill with crushed stone (CR-6) and remove excess dirt and debris; and

WHEREAS, the Mayor and Council wish to approve said invoice and proposal with said vendor to perform work at the Tot Lot on Fox Way and Mohican Drive in the amount of \$9,000 from line item 7089 of the FY2015 Budget.

NOW THEREFORE, BE IT RESOLVED that the Mayor and Town Council of the Town of Forest Heights, Maryland hereby ratifies the procurement and authorizes the Mayor to sign the above referenced proposal dated September 17, 2014 (attached hereto and incorporated by reference herein) with KC Delivery Service General Contracting, LLC, for services and materials as specified in Exhibit A.

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon passage.
