RESOLUTION 72 -14

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT ON BEHALF OF THE TOWN OF FOREST HEIGHTS TO OBTAIN ASPHALT & CURB REPLACEMENT FOR THE REAR PARKING LOT OF THE TOWN HALL FROM CHOICE CONCRETE CONSTRUCTION, INC OF BELTSVILLE, MD.

WHEREAS, the Town Council has authority to approve contracts and procurements pursuant to the Town Charter, Section 33-63, and Town Code, Section 20.4; and

NOW THEREFORE BE IT RESOLVED, that the Town Council hereby approves the bid, quote or proposal of Choice Concrete Construction, Inc. of Beltsville, MD entitled Proposal #13-610 (subject to the conditions of insurance and waiver stated below) regarding asphalt and curb replacement for the rear parking lot of the Town Hall;

AND BE IT FURTHER RESOLVED, that consideration for the above contract shall be appropriated and paid for from Line Item 8000 (Street Repair Project) of the FY 2015 Budget in the amount of \$20,000.00 and 7223 (General Bldg Repair & Maint) in the amount of \$13,145.00; and

AND BE IT FURTHER RESOLVED, that prior to the Mayor signing the approved proposal or contract of Choice Concrete Construction, Inc., of Beltsville, MD said company shall provide a certificate of good standing and proof of insurance indemnifying the Town, to the satisfaction of the Town Administrator, and that the Contractor shall agree by signing a release and waiver that it will provide and maintain at all times during the term of this agreement, or any other contract it has with the Town, such insurance coverage (Commercial General Liability, Business Automobile Liability, and Workers' Compensation) to adequately protect the Town or as otherwise required by law and that the Contractor shall cover any claim that may arise while engaged in work under any agreement with the Town; and

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon passage.
