RESOLUTION 04-15 THE TOWN OF FOREST HEIGHTS

A RESOLUTION APPROVING AN APPLICATION FOR FILING WITH THE DC PUBLIC SERVICE COMMISSION TO REQUEST CERTIFICATION OF THE PV (PHOTOVOLTAIC) SYSTEM IN THE DISTRICT OF COLUMBIA AND FOR THE PUBLIC WORKS DIRECTOR TO SUBMIT SAID APPLICATION WITH ANY NECESSARY AFFIDAVITS

WHEREAS, the Town Council has authority to approve contracts and procurements pursuant to the Town Charter, Section 33-63, and Town Code, Section 20.4, and the Town may properly dispose of property held in a propriety capacity; and

WHEREAS, the Town owns and operates a solar panel that is used to generate electricity for the production of approximately 12,150 kWh of electricity for internal use that was previously projected to obtain approximately \$5,300 in annual solar revenue (savings and income) each year; and

WHEREAS, although the Town's system is certified by the Md. PSC, in order to be qualified to sell Solar Renewable Energy Certificates (SREC's) in D.C., the Town must also be certified by the D.C. PSC to sell SRECs from a location served by a distribution feeder serving D.C.; and

WHEREAS, the Mayor and Council find that an application for certification as an eligible District of Columbia renewable energy standards generating facility is desirable and would be beneficial to the Town.

NOW THEREFORE BE IT RESOLVED, that the Town Council hereby approves and authorizes the filing of an Application for Filing with the DC Public Service Commission to Request Certification of the PV (Photovoltaic) System in The District of Columbia, attached hereto and incorporated by reference herein, according to the terms and conditions stated therein; and

AND BE IT FURTHER RESOLVED, that the Public Works Director may sign said application on behalf of the Town and may provide any necessary affidavits or other documentation necessary to carry out the intent of this Resolution; and

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon passage.
