**NOW, BE IT RESOLVED**, that funds be added to line item 6030 Parks and Planning Grant and line item 8010 Parks and Planning in the amount of \$7,500, and line item 6102 MD Smart Energy Grant and line item 7258 MD Smart Energy Grant in the amount of \$291, and line item 6106 Chesapeake Bay Trust – Rolph Drive and line item 8023 Chesapeake Bay Trust in the amount of \$90,873, and line item 6080 NFWF Rolph Drive and line item 7236 NFWF Urban Small Waters in the amount of \$160,000, and line item 6084 PG Co. Stormwater Maintenance and line item 8034 Rolph Drive Project in the amount of \$64,551, and line item 6108 Chesapeake Bay Trust - Treekeepers and line item 8040 Chesapeake Bay Trust - Treekeepers in the amount of \$18,027.

**AND BE IT FURTHER RESOLVED**, that this Resolution shall take effect immediately upon its passage.
