NOW THEREFORE BE IT RESOLVED, that the Town Council hereby approves the proposal of V & M Electric entitled proposal in the amount of \$4,200.00 regarding electrical inspection for 606 Modoc Lane and \$2,400 for the electrical inspection for the First Floor of the Municipal Building;

AND BE IT FURTHER RESOLVED, that consideration for the above proposal shall be appropriated and paid for from line item 7223 (General Building Repair & Maintenance) in the amount of \$2,400 and line item 8038 (Modoc Building) in the amount of \$8,940 of the FY 2016 Budget; and

AND BE IT FURTHER RESOLVED, that prior to the Mayor signing the approved proposal or contract of V & M Electric said company shall provide a certificate of good standing and proof of insurance indemnifying the Town, to the satisfaction of the Town Administrator, and that the Contractor shall agree by signing a release and waiver that it will provide and maintain at all times during the term of this agreement, or any other contract it has with the Town, such insurance coverage (Commercial General Liability, Business Automobile Liability, and Workers' Compensation) to adequately protect the Town or as otherwise required by law and that the Contractor shall cover any claim that may arise while engaged in work under any agreement with the Town; and

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon passage.
